### **Objectives and Investment Policy**

This Fund's objective is to provide investors with long term capital growth.

We aim to achieve the investment objective by investing in a diversified portfolio of investments in European companies (excluding the United Kingdom). At least 70 % of Fund's assets will be invested in Continental Europe.

The Fund's policy is to invest in shares listed on a European stock exchange. The Fund invests predominantly in larger companies. We may also utilize deposits and money market instruments in the management of the portfolio. The Fund may also invest up to 10 % of Fund's assets in collective investment schemes.

Benchmark of the fund is S&P Europe Ex-U.K. Large and Mid-Cap Growth in GBP.

You may redeem shares of the fund usually on each business day by 12:00.

We reinvest the income into the fund.

#### Why is the fund in this category?












